INSTRUCTIONS TO AUTHORS

TPM is primarily devoted to original investigations that contribute new knowledge and understanding to the fields of theories and instruments useful in psychological research, mathematical models and statistical methods, applied social psychology, work and organizational psychology.

All manuscripts should follow the style guidelines set forth in the fifth edition of the Publication Manual of the American Psychological Association. Journal policy prohibits an author from submitting the same manuscript for consideration by another journal and does not allow publication of a manuscript that has been published in whole or in part by another journal.

Authors must also verify compliance with ethical standards in the treatment of participants: human or animal.

MANUSCRIPTS

Manuscripts, exclusively in English, must be submitted online to the following e-mail address: tpmap@tpmap.org

Papers should not exceed 10,000 words in length, including references and notes. The word count should appear on the title page. Manuscripts should include an abstract of no more than 150 words, and beneath abstract five keywords.

Authors' names and their affiliations must be indicated on the title page, together with full contact details for one of the authors: address, e-mail address, telephone/fax.

REFEREEING

The journal operates a policy of anonymous peer review. Papers will normally be scrutinized and commented on by at least two independent expert referees. The referees will not be made aware of the identity of the author. All information about authorship, including personal acknowledgments and institutional affiliations, should be confined to the title page, and the text should be free of such clues as identifiable self-citations ("In our earlier work...").
